2024 SCHOOL FEE INFORMATION

Please note that all Policies and forms associated with School Fees are available on the school website and in hard copy from the school's finance office.

Accounts are due in full within 30 days of invoice unless you have either a Request to Pay School Fees by Instalment or Fee Concession Arrangement in place.

REQUEST TO PAY SCHOOL FEES BY INSTALMENT

All families who require flexible payment arrangements must have a current Request to Pay School Fees by Instalment. This agreement gives advice to your school regarding your preferred method, frequency and amount of your payment. If you do not have a current agreement or you would like to amend your existing, please download from the school's website and submit to the school office.

FEE CONCESSION APPLICATIONS

If your family will experience difficulty in payment of fees, an Application for Fee Concession must be made. Applications are available on the school's office. Applications are not considered without supporting evidence, an interview with the Principal and any concession granted is subject to an annual review.

LEAVING EARLY/COMMENCING LATE IN THE SCHOOL YEAR

Please refer to the Diocesan 'Diocesan School Fee Method of Calculation' if your child or children leave or commence school during the year and therefore does not attend for a full year. These guidelines give advice in relation to what fees will be charged or refunded.

Dear Parents/Caregivers,

This is an outline of the level and purpose of fees for students attending Magdalene Catholic College in 2024.

Government funding covers approximately 80% of the recurrent costs associated with running a Secondary Catholic College. The 20% "gap", plus loan commitments associated with building; need to be met by parent contributions. A breakdown of the 2024 school fees is:

Tuition FeeTeachers' salaries and the day to day running costs of the college (water, electricity, paper etc.)

Building Fund

This levy is used solely for the repayment of loans on the college buildings (equivalent to a

mortgage payment). 50% discount applies to 2nd child, 100% discount for 3rd child attending the college. *The Building Fund cannot be claimed as a Tax Deduction as it is a Compulsory Charge*.

Technology LevyThis contributes towards the costs of maintaining technology hardware, software and access to

the internet.

Resource Fee This covers the cost of all subscriptions, textbooks (hard copy and electronic) and equipment

which are purchased in bulk and issued to students for their personal use.

Elective Course Fees Elective Fee covers all consumables for the Course. Refunded on a pro-rata rate if the student

leaves prior to the end of Term 3

Sport/TAFE Levy All students rotate through four sports blocks over the year which includes swimming, indoor

recreational sports, elective choices (e.g. martial arts, aerobics, dance etc) and college-based sport. In addition, students may trial for inter-school competitive sport. The sports levy covers <u>all costs</u> associated with sport including whole college Swimming/Athletic/Cross Country carnival venue costs, bus travel, external and internal sport providers, ongoing maintenance of school sporting facilities, ongoing maintenance and purchase of new sport equipment, F1 College based costs, First Aid packs and external First Aid providers at all whole college sporting carnivals. This

levy also covers the transportation of students who attend TAFE on Tuesday afternoon.

Parents & Friends Levy The P&F levy of \$120 per family, per year replaces major fundraising activities for parents. This

then allows the P&F to concentrate on special gatherings with an emphasis on community

building, rather than fundraising.

PAYMENT OF SCHOOL FEES

With the Diocesan change to the distribution of an annual school fee account, the tuition fee, building fund, sport levy, P&F levy, administration fee, Resource fee, elective fees, yearbook fee, technology levy and Retreat/Camp and excursion costs, will be billed in Term 1 of each year.

Fee accounts are posted early in Term 1 and are a 30-day account. Payments may be made in a lump sum, or once a Diocesan School Fee Agreement form has been completed and submitted, payment can be made in instalments. Accounts may be paid via the COMPASS portal BPAY, EFTPOS, cash, or credit card.

A deduction on the tuition fee only, for the second and subsequent child of a family attending the Magdalene applies. Deductions are as follows:

for the second child attending the school. for the third child attending the school.

for the fourth and subsequent children attending the school.

All families however are required to pay all other fees and levies. Any family experiencing difficulties regarding the payment of fees must contact the Principal. Such matters are always treated in the strictest confidence.
